TERMS & CONDITIONS

This space application form will be governed by the following terms and conditions. These terms are non-negotiable unless specifically agreed to in writing by **Global Events and Expositions Private Limited**.

Exhibitors are advised to review the terms and conditions thoroughly before finalizing their participation.

- 1) For purposes of this space application form the word "**Organizer**" will refer to **Global Events and Expositions Private Limited** having their registered office in New Delhi and the word "**Exhibitors**" will refer to the person and / or company who has completed this space application form.
- 2) There are 2 options for stall space in each city 4 Sq. Mtr. Stall and 6 Sq. Mtr. Stall. **Goods and Service Tax (GST) @ 18.00%** is charged extra.
- 3) The booking of space has to be made along with **100% advance payment** by way of wire transfer in favor of **Global Events and Expositions Private Limited** along with the space application form duly filled and signed by the competent authority.

- 4) All Exhibitors are required to comply with all the provisions of Goods and Service Tax (GST) act regulations or any tax and levies as applicable by Government of India enforceable at the time of the Fair.
- 5) Space locations will generally be allocated on a first-come, first-served basis. However, the Organizer reserves the right to assign space locations based on categorization, and their decision in this regard shall be final.
- 6) Exhibitors should note that all floor plans are tentative and the Organizer reserves the right to make changes. Additionally, the Organizer is not liable for any changes to the venue or date due to circumstances beyond their control.
- 7) The Organizer may cancel, suspend or alter dates of the exhibition owing to circumstances beyond their control. Only in the event of cancellation, Exhibitor will receive a 85% refund of the space rental after deducting proportionate costs already incurred by the Organizer. In case of change in dates, venue, duration and timing of the exhibition the contractual obligation between the Exhibitors and the Organizer remain unaffected. In any such case the Organizer will not be responsible for any consequential liability or loss whatsoever incurred by the Exhibitors.
- 8) If the event is canceled or suspended in whole or in part due to reasons beyond the Organizer's control, such as force majeure, the Organizer will not be liable for any refunds and will not accept any consequential liability. Disputes will be subject to the jurisdiction of New Delhi courts only.
- 9) The Organizer will not refund money for cancellations made by Exhibitors who have booked the space, except in cases of uncontrollable major circumstances such as natural disasters, pandemics, or extraordinary intergovernmental issues.
- 10) The Organizer reserves the right to cancel the space booking or order at any time before or during the event by refunding the received money at their sole discretion and without providing a reason. If the space is canceled due to the Exhibitor's misbehavior, no refund will be issued.
- 11) In case the Exhibitors does not take possession of the space by 10 am on the opening day the Organizer reserve the right to allot the space to others without refunding the participation charges already received.
- 12) The Exhibitors cannot sublet the space to third parties, transfer the space, and utilize the space other than the purpose for which the said space has been contracted. Rights of an Exhibitor shall not be assignable to any other firm or person and no Exhibitor may assign their space, or sublet the whole or any part of the space contracted for.
- 13) The execution of the space application form and its receipt by Organizer is deemed conclusive evidence of the Exhibitors agreement to the terms and conditions and pay the full fees due from that moment. The application form is non-cancelable by the Exhibitors.
- 14) No Exhibitor will be allowed to exhibit unless all agreed fees from the previous page have been paid prior to the exhibition.
- 15) Space application form will be deemed complete only after the Organizer have accepted the booking.
- 16) The Organizer shall have a lien over the Exhibitors goods in case of their default in any manner.
- 17) The Exhibitors acknowledges that Organizer, having incurred expenses as a result of the application form, is not required to refund any of the fees agreed to on this application form and that Organizer is entitled to recover any unpaid amounts that the Exhibitors may owe to them.
- 18) Although arrangements for security will be made by the Organizer, the Exhibitors will be solely responsible for the safety of their goods.
- 19) Exhibitors are advised to bring their own stabilizers, UPS units, and spike busters to ensure a stable power supply for their equipment, as the Organizer cannot guarantee consistent power supply.
- 20) Exhibitors are expected to comply with any building regulations and all Government rules and regulations.
- 21) Goods, Materials, Objects which are hazardous, inflammable, banned, forbidden, or deemed inappropriate by the Organizer will not be allowed in the venue.
- 22) Exhibitors are fully responsible for any damage to premises, furniture, or fixtures, with the Organizer's decision being final.
- 23) No Exhibitor may remove their setup from the exhibition floor before the official end of the event, and must have an authorized representative present at all times during the exhibition, including installation and dismantling periods.
- 24) Disassembly and removal of all materials will have to be done on the same day after the end of the show.
- 25) The rates do not include charges for extra lighting or decoration, demonstrators or sales personnel etc, which may be arranged on specific requests at extra cost to be paid in cash by the Exhibitors at the venue.
- 26) Setup should not obstruct the view of adjoining stalls nor be operated in any manner objectionable to other Exhibitors. All lighting within the space must be arranged and operated and should not be distracting to adjacent stalls. Phonographs, radios, or other sound devices operated in a manner deemed objectionable by the Organizers or other Exhibitors shall be prohibited.
